## **ETHICS**

Please elaborate below on your agenda to improve ethics in New York state government. What do you see as the main flaws in the current system? What policies would you implement to correct those flaws? What actions you plan to take to advance your positions on ethics issues.

As US Attorney Damian Williams said at his April 12 press conference announcing bribery and corruption charges against Lieutenant Governor Brian Benjamin, "Public corruption remains a problem in New York. It is a bipartisan problem. It is an ongoing problem." Last August, The Washington Post ranked New York as the #1 most corrupt state in the country, and it is no surprise given all the elected officials who have left office in scandal.

Unfortunately, despite saying "A new era of transparency will be one of my hallmarks of my

administration" and "We'll focus on open, ethical governing that New Yorkers will trust", Governor Hochul has made the culture of corruption worse: - Her handpicked Lieutenant Governor was forced to resign after being arrested.

- She gave the billionaire owners of the Buffalo Bills the largest taxpayer-funded handout in NFL history, jamming it into the state budget at the last second after a secretive negotiation with no public debate.

- After refusing to release her daily schedules to the public for months, the schedules she has released show an unprecedented amount of time spent at fundraisers with lobbyists. They also showed abuse of taxpayer-funded state aircraft that forced her to reimburse the state for tens of thousands of dollars.

We need common sense reforms that will increase transparency and restore New Yorkers' faith in the Office of the Governor. That is why I have laid out my 6-Point Government Accountability Plan:

1. Any expenditure over \$10 million not included in the Executive, Senate, or Assembly Budget that is added later in the budget process (like the Buffalo Bills stadium) must be subject to legislative hearings.

2. Adopt federal campaign finance laws: Lower contribution limits to \$2,900 and prohibit corporate donations.

3. Require quarterly campaign financial disclosure filings.

4. Reform JCOPE into a truly independent ethics commission. Governor Hochul's proposal does not do so because it still allows elected officials to play a role in choosing the people meant to oversee their behavior.

5. Ban the use of state aircraft for non-official events in order to prevent the abuse like we've seen from Governor Hochul.

6. Ban the promotion of statewide elected officials in taxpayer-funded, unsolicited mass communications within 90 days of elections. Doing so would prevent situations like the one we recently had, where a taxpayer-funded advertisement from the New York Power Authority served as a de facto Hochul campaign advertisement.

### What experience have you had, if any, with

### ethics reform? If you have worked to advance this issue (as a lawmaker, public official, professional, or a private citizen) we would like to hear about it.

When I was Nassau County Executive in 2004, I launched a campaign called "Fix Albany", a statewide political action committee whose goal was "to root out corruption in the New York State government, reform the Legislature, and hold State legislators accountable for their non-action to help County and local governments."

When I launched Fix Albany, I was applauded for finally going after the corruption that had for decades been entrenched in the State Government. The New York Times praised "Suozzi's Excellent Idea!" Newsday issued a call to "Support Suozzi's Challenge." The Buffalo News lauded me for "Going After Albany." The Staten Island Advance said "Right on to Suozzi's Revolution."

Prior to starting Fix Albany, I'd faced immense resistance when even asking for a meeting with the power players of the New York State Government, many of whom would ultimately succumb to ethics scandals themselves (Sheldon Silver, Joe Bruno, Dean Skelos, etc.). I decided to run a challenger Democrat against an incumbent Democrat in a State Assembly primary and a challenger Democrat against an incumbent Republican in a State Senate general election. Sure enough, both of the challengers I backed won their races, and those guys started to listen to me. That's why I was able to get a Medicaid Cap passed that saved New York City and the counties billions of dollars.

When I ran for Governor a couple years later, The New York Times Editorial Board reflected on my Fix Albany campaign, saying, "Suozzi was earlier (than Spitzer) in recognizing that New York's state government is a mess and that its irresponsibility threatens local governments as well. And unlike the vast majority of politicians who complain that Albany needs fixing, he did something about it, risking his own political capital to back candidates against entrenched incumbent state legislators. That kind of gumption is rarer than any other political virtue in New York."

## **Ethics Oversight**

Do you support replacing Joint Commission on Public Ethics with an effective and independent enforcement body, whose members are not appointed directly by elected officials?

# **ELECTIONS AND VOTING**

### **Election Administration**

### How would you use your power as a governor to improve election administration in New York?

Election administration in our state is seriously deficient. It often takes weeks to count ballots and determine who won an election, which can undermine the public's faith in the democratic process. As Governor, I will hold a statewide conference with the Boards of Elections and develop a system of best practices.

### What experience have you had, if any, with election reform? If you have worked to advance this issue (as a lawmaker, public official, professional, or a private citizen) we would like to hear about it.

When I was in law school, I received the New York State Bar Association's Ethics Award for my pro bono work on the New York State Commission on Government Integrity and helped draft its report. As a public official for over two decades, I have always encouraged open, fair, and transparent elections and have long advocated for campaign finance reform.

I still think that the Independent Redistricting Commission is the body best suited to draw maps. However, we saw this past year how partisanship prevented the Commission from submitting a consensus map with bipartisan support. Ultimately, the best and perhaps only way to get partisanship out of the redistricting process is to pass federal legislation banning partisan gerrymandering and requiring independent redistricting commissions in all states.

# **CAMPAIGN FINANCE**

### How would you use your power as a governor to reform the campaign finance system in New York and reduce the role of big money in campaigns?

A key piece of my 6-Point Government Accountability Plan is aligning New York's campaign finance rules with the stricter rules the federal government has. I would sign a law limiting campaign contributions to \$2,900 for the primary and \$2,900 for the general election, the same as for federal offices. Right now, statewide Democratic candidates can receive \$22,600 for the primary and \$47,100 for the general election.

### What experience have you had, if any, with campaign finance reform? If you have worked to advance this issue (as a lawmaker, public official, professional, or a private citizen) we would like to hear about it.

In Congress, I have consistently received an 'A' rating from End Citizens United, whose goal is to reduce the role of big money in politics. As a candidate for Governor, I have made my campaign finance reform a major piece of my platform. For too long, New Yorkers have been forced to deal with the consequences of Albany's culture of corruption, which largely stems from the influence of big money donors. As Governor, I will sign \$2,900 contribution limits into law.

# Do you support further reducing campaign contribution limits?

There is not enough transparency or public input in the budget process. That is why my Government Accountability Plan includes a requirement that any expenditure over \$10 million not included in the Executive, Senate, or Assembly Budget that is added later in the budget process must be subject to legislative hearings. Such a requirement would have required last minute additions this year like the Bills stadium and the \$350 million Long Island giveaway to be subject to public debate.

Having a government reform agenda like I do is one thing, but you also need to be able to implement that agenda. Too many New York politicians are good at giving a speech but don't have the ability to overcome the culture of corruption that is so engrained in New York politics. I was excited when Governor Hochul promised "a new era of transparency" and "open, ethical governing that New Yorkers will trust", but we've seen that things have only gotten worse during her tenure. From Brian Benjamin to the Buffalo Bills to the secretive, rushed budget, Governor Hochul has not only failed to fix the culture of corruption in Albany, she has become part of it.

I am the only Democratic candidate with a proven track record of success as a reformer of the New York State Government. My Fix Albany fought back against Albany corruption on behalf of New York taxpayers. As Governor, I will finally bring the change that Albany so desperately needs. I hope to have your support.

# What else would you like us to know about yourself?

Everything I've done in my career has prepared me for this particular job at this particular time.

New York is in trouble. When I was born, we had 45 Members of Congress. Today, we have 27 and we are about to go down to 26. We are losing influence because we are not growing as quickly as the rest of the country. From 2020 to 2021, we lost 300,000 residents, the largest outmigration of any state in the United States, and more than Illinois, Massachusetts, Pennsylvania, Michigan, and New Jersey combined.

New York faces serious problems with crime, affordability, troubled schools, and government corruption. I am the only Democratic primary candidate with 1) the proven executive experience, 2) the common sense approach to governing, and 3) the vision to make the New York State Government successful once again.

#### 1) Proven Executive Experience:

I am the only candidate in the field with years of experience and a long track record of accomplishment as a chief executive. I served as Mayor of my hometown of Glen Cove for eight years and as County Executive of Nassau County, with a population and budget larger than 11 states, for eight years. When I took over as Nassau County Executive in 2002, we were on the brink of bankruptcy, our social services were a mess, and our physical infrastructure had deteriorated. During my eight years in office, I restored the fiscal health of the County, I brought a revolutionary "No Wrong Door" human services delivery system to those most in need, I championed a \$150 million environmental restoration program, and I dramatically upgraded the County's physical infrastructure and technology.

2) Common Sense Approach to Governing: While I am a lifelong Democrat who will always advocate for my progressive values, I have learned throughout my career that in order to get things done that will make peoples' lives better, you need to be willing to work with people who you disagree with. I will work with anyone, whether they are progressive or moderate, Democrat or Republican, to make New York the best that it can be.

- Fighting crime

- Lowering taxes and making New York more affordable

- Helping our troubled schools
