ELECTIONS AND VOTING

Election Administration

How would you use your power as a legislator to improve election administration in New York? Feel free to add any policy proposals you support in regards to reforming the BOE.

The New York State Legislature should pass Senate S6226A/A5691B, which clarifies the roles and responsibilities of commissioners and the co-executive directors of the NYC Board of Elections. I would also work to get Senator Myrie's suite of election law bills pass in the Assembly which includes creating conflict-of-interest standards for commissioners and sets minimum staffing levels for Boards of Election. We should also enact automatic voter registration, and allow folks who show up at the wrong polling location to still vote at that location.

Do you support removing the constitutional requirement in election administration that empowers the two major political parties to nominate and effectively control election boards?

GOALS, PLANS, AND REPRESENTATION

What are the top three campaign promises or goals, and what action will you take to achieve them if elected? Feel free to reference an answer above rather than restate it.

First: Putting Families First: universal childcare, ensuring our public schools are fully funded

Second: Accountable Governance: more transparency and balance to our budget process, public participation in committee meetings, restoring the comptroller's oversight of contracts

Third: Climate Action: committing \$15 billion to climate justice

If elected, what is the first piece of legislation you would want to introduce? If you are an incumbent, what is the first piece of legislation you would want to pass?

I would introduce a bill that would create a year-round legislative session, as opposed to the 6 months legislators are currently in Albany.

In providing constituent service, what are the major needs of your district's constituents and how will you meet them?

One of the biggest concerns of District 73 constituents is the hollowing out of small businesses from COVID-19, which has impacted both individuals and communities. This is clearly evidenced by empty storefronts throughout the district. I would support incoming small business owners in navigating red tape and bureaucracy.

District 73 is an older demographic, and many of its residents are concerned about their ability to age in place. A component of this is ensuring adequate infrastructure, such as elevators and escalators, to support mobility needs.

What experience have you had, if any, with good government and reform issues? (e.g. voting and elections, campaign finance, ethics, government transparency and oversight, police accountability). If you've worked to advance these goals, we'd love to hear about it.

As a co-lead of Empire State Indivisible, I've helped educate others about and advocated directly to elected officials on, extensive voting reforms through the Fair Elections Coalition. I also helped organize people to testify on the then-

proposed Public Campaign Finance program.

How long have you lived in the district in which you are running?

I've lived in NYC for almost a decade, specifically on the east side in Manhattan.

Have you lived in the district before this year's redistricting?

For incumbents: If your district has changed significantly following this year's redistricting, how do you intend to run your office to serve the needs of the new constituents you now represent?

PATH TO VICTORY

What is your win number (the number of votes needed to win this race), and what is your plan to achieve that number?

Because this is a deep-blue district, our team will be laser-focused on winning the June 2022 primary. The current district includes 61,032 registered Democrats. Past voting trends indicate that 25% of registered voters will show up in the 2022 primary, totaling 15,258. Knowing that there may be a slight uptick due to the gubernatorial election, and there are five candidates total, my win number is 7,400. I am focused on cultivating support from key stakeholders in the community, with an eye towards inclusion, transparency and trust-building.

I am the only candidate who has worked around the world to better people's lives AND has translated that work here on the ground in New York for years to do the same. Unlike my competitors, my decade of domestic organizing experience has been focused on change in Albany, not just New York City, giving me the requisite network, experience, and understanding of the issues to be able to hit the ground running. I am also the only candidate that has worked to ensure the RHA was passed at the state level by defeating the IDC.

The breadth of my worldview has shown me that our "uniquely" New York problems are not so unique – a perspective that gives me the insight and experience to help address the complex issues facing us right now, such as COVID recovery, climate change, and crumbling infrastructure. We need to apply better, smarter, more forward-thinking approaches – wherever we can find them – to our problems here.

What else would you like us to know about yourself?

I helped co-found Empire State Indivisible (ESI) based on a recognition that the status quo was immoral and leaving too many behind. ESI is based on the belief that we need to transform city, state and national politics to build a more compassionate and more equitable New York. ESI works in collaboration with partners throughout the state to strengthen our democracy, advocate for a more just state budget, and support progressive democrats. In 2018, ESI worked in collaboration with coalition partners to take down the fake Democrats in the N.Y. State Senate, known as the "Independent Democratic Conference," and since then has worked to rebuild a more accountable state government.

My life's work has centered around improving people's lives, and I pledge to do the same for the people of District 73. In senior leadership roles with the International Rescue Committee and NYU's Development Research Institute I gained a global perspective that informs my approach to local public office. In 2017, I co-founded the Refugee Self-Reliance Initiative, hosted by the Women's Refugee Commission and RefugePoint, an industry-leading collaboration that promotes opportunities for refugees to get back on their feet and achieve a better quality of life while simultaneously advocating for the full enjoyment of their rights. I currently serves as US Board Chair of Urban Refugees, a leading organization in supporting refugee-led organizations in East Africa.

I am also an Adjunct Assistant Professor at NYU's Robert F. Wagner Graduate School of Public Service and have a Masters in International Education from Columbia's Teachers College. I'm a long-time mentor with the Lower Eastside Girls' Club. As the daughter of a proud, card-carrying. New York State United Teachers' member, and now sitting in front of a classroom herself, I understand that there is nothing more important than ensuring a bright future for our children with a high-quality education. I am also firmly committed to delivering affordable child care for our working families. This has never been more important than it is now.
