In providing constituent service, what are the major needs of your district's constituents and how will you meet them?

It has been over 50 years since District 75 has had an open election for Assembly office. I am fortunate to bring with me a repertoire of communications and campaign management experience. I have surrounded myself with a team of leaders with diverse backgrounds and skillsets who bring passion and dedication not only to this race but to bettering our community at large.

I have an expansive campaign coalition consisting of union retirees, small business owners, students, active union members, parents, block association leaders, precinct council leadership, tenant advocates, and community board members. My base consists of members of my community that are long engaged voters and new voters alike ready to get to work to build a district that is a part of the solution to fight climate change, the ongoing COVID-19 emergency, address our growing housing crisis, and proactively address issues of race and gender equity.

This campaign is more than just a bid for political office; it is an opportunity to bring real, progressive change to our district. Engaging with the community, garnering support from local civic and tenant organizations, promoting voter equity and accessibility are the foundation on which I will build and ultimately win my race. If the election ended today and I had to build a constituent service team, I am the only candidate in this race who would be able to do so day 1.

I have years of experience as a political strategist under my belt; having served as political director, deputy campaign manager, co-chair and communications manager for a number of high-profile local campaigns. I also served as the Legislative and Communications Fellow for New York City Council's Black, Latino, and Asian Caucus, organizing for equal pay of EMS, 2020 Census outreach in our immigrant communities, and funding for RCV education. I worked as the Policy and Communications Director for the former City Council Chair of Public Housing. This work led to tracking and working with NYCHA leadership and the Federal Monitor.

I have served for the last five years as a member of Manhattan Community Board 4. During which I led the conversation on aid in the Small Business Taskforce and sat on both the Arts Culture Education and the Streetlife committee. I represented the board on the Mayor's Mental Health Public Awareness campaign, on the Waterfront Parks and Environment committee, negotiated the prioritization of funding for the development of Hudson River Park's Pier 97 and on the important Clinton Hell's Kitchen Land Use committee. I am also the founding president of the 47th Street Tenants' Association, successfully organizing his neighbors against an illegal hotel ring and returning sorely needed housing back on the rental market.

I am a past executive committee member of the Manhattan Young Democrats, spearheading the initiative to have more millennial and Gen-Z engagement and representation on these vital government boards. Currently I am in my third year as an executive member of the Hell's Kitchen Democratic Club.
