Born and raised in Bay Ridge, Brooklyn, Andrew knows firsthand the value of putting communities first. Following Superstorm Sandy, Andrew co-founded Bay Ridge Cares, an organization that prepared 25,000 hot meals for victims after the storm. As a member of the Riders Alliance, he organized and formed the Concerned R Train Riders to fight for better service and demand accessible subway stations in Southern Brooklyn. Andrew also worked with Bay Ridge Advocates for Keeping Everyone Safe (B.R.A.K.E.S.) and successfully pressured lawmakers to allow speed cameras in school zones, a fight he continues to wage up in Albany. He is a past president of the Bay Ridge Historical Society and a former member of Community Board 10.

Andrew and his wife Melanie live in Bay Ridge, where they are raising their son Evan. Andrew is a graduate of local parochial and public schools, Hunter College -CUNY, and the George Washington University Law School. He is a founding member of the Hellenic-American Leadership Council.

ETHICS

What is your opinion on the recently passed ethics reform, which replaced JCOPE with a new ethics oversight agency called Commission on Ethics and Lobbying in Government? Did you support this policy?

While replacing JCOPE was sorely needed to restore confidence in the integrity of Albany, I don't believe that the Commission on Ethics and Lobbying in Government goes far enough to ensure the appropriate level of independent accountability. I was one of 12 Senators to sign a statement opposing the Governor's plan and was disappointed that we could not craft a more independent oversight body. I did end up voting for the budget that included the Governor's ethics reforms, but believe that we have more work to do to clean up Albany.

Do you support the new independent ethics oversight agency to also replace the Legislative Ethics Commission (LEC)?

ELECTIONS AND VOTING

Election Administration

How would you use your power as a legislator to improve election administration in New York? Feel free to add any policy proposals you support in regards to reforming the BOE.

Just a few ideas to reforming election administration: amend the constitution to remove the party-parity requirement for BOE commissioners in favor of a non-partisan governing structure; implement and enforce anti-nepotism hiring standards for BOE staff positions; reform poll worker recruitment, including removing political party leadership preferences for poll worker placement and allowing CUNY and SUNY students to receive course credit for serving as poll workers (S9058 Gounardes); and improving language access at the ballot using technology and ondemand ballot printing.

This past year, the Senate voted on a number of BOE reforms, including mandatory training for election commissioners, increasing pay for poll workers and inspectors, and reforming certain practices of the NYC Board of Elections.

Do you support removing the constitutional requirement in election administration that empowers the two major political parties to nominate and effectively control election boards?

I do not have the full answer to this constitutional and public policy problem yet, but at a bare minimum, we need to either reform the current IRC - and the constitutional process it must follow - or create a new redistricting body & process that does not end in stalemate and does not allow for partisan drawing of district lines.

GOALS, PLANS, AND REPRESENTATION

What are the top three campaign promises or goals, and what action will you take to achieve them if elected? Feel free to reference an answer above rather than restate it.

First: Fully fund the City University of New York and pass the New Deal for CUNY

Second: Combat sexual harassment in the workplace by banning NDAs and removing other practices that shield abusers

Third: Reinvest in public infrastructure to reimagine the BQE and create a fully reliable and accessible transit system

S9293A - my legislation to extend anti-SLAPP protections to victims who file claims of workplace harassment or discrimination

In providing constituent service, what are the major needs of your district's constituents and how will you meet them?

The 26th District runs from Dyker Heights and Bay Ridge, up through Sunset Park and Gowanus, and then terminates at Brooklyn Heights and Vinegar Hill. There is a myriad of issues that concern these residents, but a few that span across neighborhoods and have a districtwide impact. Among the top issues of concern:

-- transit accessibility and reliability - with the totality of the R line in Brooklyn, as well as the F,G,N,D,Q,A,C,2,3,4,and 5 trains all serving this district, and the plethora of bus lines, this is a district that requires a functioning and reliable transit system.

-- climate change and waterfront resiliency - the coastal communities of Sunset Park, Red Hook, DUMBO, and Vinegar Hill are all scarred from the devastation of Superstorm Sandy; knowing that we are one-storm surge away from devastation yet again makes climate change and waterfront resiliency a top concern.

-- BQE and trucking - more than half of the BQE's 17 miles is included in this district, from the Verrazzano Bridge to Sands Street, which makes the future of this corridor, including the structurally unsound cantilever, a significant concern. Any

proposals to address the BQE must take into account the explosive growth of trucking freight across the NYC region, including the proliferation of last-mile warehouse distribution centers across Sunset Park and Red Hook.

-- street safety - as long as traffic fatalities continue to climb, there will always be a need to continue to curb reckless driving and making streets safer for pedestrians and cyclists.

My approach to constituent service is to meet the voters, hear their concerns, and bring my office to them-- to be as accessible as possible and include as many voices around the table as I can. Working together with community stakeholders will allow my office to proactively address the many long-standing challenges that this district has.

What experience have you had, if any, with good government and reform issues? (e.g. voting and elections, campaign finance, ethics, government transparency and oversight, police accountability). If you've worked to advance these goals, we'd love to hear about it.

Since my election in 2018, I have worked to introduce and support bills around government ethics and transparency, curbing workplace harassment and discrimination - including holding government officials accountable for their own malfeasance, reform antiquated election laws, and support public financing of elections.

Do you currently live in this district? How long have you lived in it?

Yes. I was born and raised here.

Technically, I do not yet represent the new parts of the district that I am running to represent next year. As such, my office is still committed to serving my existing constituents as best as we can, while I work to introduce myself to new neighborhoods and new constituencies through my campaign's efforts.

Once re-elected, I plan to represent these new constituents the same way I do my current ones: with a laser focus on constituent services, thorough and accessible constituent communications, and a sincere commitment to meeting new people

and hearing from new voices.

PATH TO VICTORY

What is your win number (the number of votes needed to win this race), and what is your plan to achieve that number?

District 26 has some of the highest voter turnout in New York. We expect, while not 2020 or 2018 numbers, engagement will still be high. Following the statewide primary and an analysis of its turnout numbers, we will likely hone our goals a bit, but as of right now we are aiming for 53% of 44,000-50,000 voters, putting our win number in the 23,000-25,000 range. We expect the race in NY-10 will affect this.

We are pursuing an aggressive strategy utilizing a blanket digital media presence, mail, and an extremely robust direct voter contact/canvassing operation, which aims for two passes of our double-and-triple prime universes. Additionally, we are planning an intensive outreach campaign early on targeting likely absentee voters.
