Regarding elections and voting, I support the aforementioned reforms as well as an automatic, opt-out system for mailing absentee ballots to all registered voters. This addresses safety concerns during the pandemic as well as the many access issues that keep NY turnout as one of the lowest in the US. I would also consider working to make both primary and general election days statewide holidays.

Regarding campaign finance, I support reforming the "matching funds" program and spoke about this with City Limits last year. I advocate creating a campaign finance program that includes comparatively low spending caps and public direction of funding akin to Seattle's program of "democracy vouchers". https://citylimits.org/2019/10/09/city-campaign-finance-system-charts-path-and-highlights-challenges-for-state-reform/

Regarding the budget process, we need to reform executive budgeting wherein the governor is allowed to legislate via the budget. New Yorkers deserve a non-partisan legislative budget office.

## Government under the COVID-19 outbreak

information about school reopening, or help with unemployment insurance, it's incumbent upon elected



officials to truly serve their communities right now.

## Serving the public under the COVID-19 outbreak

### 18. What are your concerns regarding the use of emergency powers during this crisis, and how do you think NY government can maintain public accountability standards at this time?

The best thing the legislature could do is to convene through the crisis so that the state is less reliant on executive orders. There should also be a short expiration to all executive orders, which places pressure on the legislature to make them into law.

### 19. What are the biggest challenges in your district in dealing with the coronavirus outbreak?

Parents are worried about schools reopening. Families are also worried about working from home while sharing teaching duties. Residents living in long-term care facilities are worried about catching coronavirus.

The biggest challenge in dealing with all of these is to ensure everyone feels they have the support they need whether through adequate training or financial help.

#### 20. What are the appropriate roles of city, state, and federal governments in a crisis such as this?

The role of the government is to keep people safe, keep people housed, keep people fed, and keep people employed. The role of the government is to keep businesses open, to cancel financial burdens, to create mandates (like mask-wearing), and to get control over the virus before opening any essential services back up.

### 21. How will you help your future constituents, residents and businesses, access potential funding from the Coronavirus Aid, Relief, and Economic Security (CARES) Act, or any other future government relief funds?

Staff will be dedicated to outreach to both businesses and residents who are most impacted by the crisis and in most need of relief. I will also work to mobilize my colleagues to create oversight to ensure that any future relief is put into the hands of constituents, not to fill holes in the budget that could be filled by increasing taxes on the wealthy.

I will advocate and advertise for businesses and residents to contact my office while also organizing and advocating for more relief funding. I will spend time organizing with my colleagues to support AM Niou's

Bill A10826 to cancel rent and mortgage payments. New Yorkers shouldn't be rent-burdened because of a pandemic.

I advocate rent cancelation, for both commercial and residential renters.

### ETHICAL REPRESENTATION OF CONSTITUENTS

Citizens Union believes that all New Yorkers deserve to be represented by officials who work for the public interest and honor the public trust. With the corruption conviction of recent legislative leaders, we seek to endorse a candidate who will demonstrate that they will honor the full commitment of the oath of office, and always represent the public interest above all else.

### Please tell us how you have and would continue to conduct the political affairs of this office in an upright manner, and maintain the public trust.

I support public disclosures and full transparency for elected officials. However, transparency isn't the same as accountability. As an elected official, I will endorse, support, and create legislation that ensures fiscal and legislative accountability to my own constituents as well as residents throughout the state.

I also have a public history as a teller of hard truths. I stood up to criticism for outing a friend, who I discovered was a long-time, well-known sexual harasser at a county Democratic convention. I was more concerned with the future dignity of New York politics than my own political future.

I've spent the last 95 days (as of this writing) as the organizer of the nightly gathering for black lives outside Gracie Mansion, known as UES4BLM. I have worked to ensure the physical safety of my neighbors through de-escalation training and training of protest marshals for our nightly march. I have put myself in harm's way when agitators have attempted to harm protesting neighbors.

While I'm not yet serving in public office, I spend time each day considering my role as a community organizer with solemnity, sobriety, and seriousness. I will continue to honor this community by serving with dignity and honesty.
