## SERVING CONSTITUENTS

1. For most New Yorkers, the most important thing that their council members do is provide constituent services. How would you run your office to serve your community needs? Please give specific examples.

My office will be responsive and transparent. As President of the Hunters Point Civic people reach out to me all the time on community problems. I respond promptly, help where I can or put them in touch worth the organization that can. We will also have multiple language capacity to serve our diverse district and have a log where people can understand how we work on their issues.

#### 2. If you served as an elected official, what did you do to help your constituents during the Covid-19 pandemic? Please be specific.

I did not serve as an elected official but 1st I worked with LIC Relief and for 2 months I delivered food to the doors of those who could not get out. I also delivered masks and medical equipment to Elmhurst Hospital at the height of the epidemic. Then I founded a food pantry and we have now after 1 year served over 100,000 people, making sure no one in our neighborhoods would go food insecure.

13 years and my father grew up here.

Disfunctional. The Board of elections needs to be transparent, non-partisan and professional, I will work to achieve that.

#### 6. Do you consider yourself a supporter of Ranked Choice Voting? How will you work to maintain this system and educate voters on how it works?

Yes I am a supporter. I will fight to keep this and make sure all know how it works. My campaign has already created 2 videos, one in English and one in Spanish, to explain Rank Choice Voting in our area. called "How does Ranked Choice Voting Work?" It is posted on Youtube and links to other resources on Rank Choice Voting.

7. The next City Council will appoint members to the city's redistricting commission and decide whether to approve or reject the commission's districting plans. In doing so, future council members will be responsible for shaping a fair political map for the coming decade. If elected, what would your approach be in proposing or voting to appoint commission members, and in considering proposed district maps?

The members of the commission must be truly independent, not just from political parties but also incumbents and special interests. I will make sure commissioners are truly independent and will work to reflect the how communities are truly shaped and consider gender, language, ethnicity and other important factors so that all may be represented fully and fairly. 8. ## POLICE ACCOUNTABILITY

Citizens Union has been studying police accountability and performance in New York City for more than a decade. In our reports and advocacy efforts we have urged city government to strengthen the accountability of the New York Police Department to the public and create a more cohesive system of police oversight. Previous reports include: <u>2016 issue brief</u>, <u>2013 position brief on Stop and Frisk</u>, <u>2012 report on the CCRB</u>, <u>2008 policy statement on police misconduct</u>. Citizens Union's 2021 agenda for police reform, <u>published as a report</u> in March, calls for establishing a Deputy Mayor for Public Safety, allowing the CCRB to appeal the Police Commissioner's decisions, making the appointment of Police Commissioner subject to advice and consent of the City Council, consolidating agencies with oversight authority, ending qualified immunity, and more.

## HOW CITY COUNCIL WORKS

One of the first items on the next City Council's agenda will be adopting its rules of proceedings. Those rules will have a substantial effect on the ability of lawmakers to advance their goals, and can send a signal to New Yorkers about elected officials' commitment to making the Council more representative, deliberative, accountable, and efficient. In the last decade, the Council took important steps to reform its rules, including a 2014 overhaul by then-Speaker Melissa Mark-Viverito and a 2018 administrative change by Speaker Corey Johnson. These reforms have made the body more democratic, given members a more meaningful role in the legislative process, ensured greater equity in the allocation of discretionary funding, and made drafting procedures more transparent. Still, more work is needed enable members to function more effectively and independently of the speaker, and to increase public participation.

The Council Speaker has too much control. Power needs to be de-centralized to members os the members can be more effective for their constituents. This will also foster more collaboration and discussion between members.

18. The ability of citizens and advocates to make their voices heard in City Hall has been severely curtailed since the council and city government shifted to work remotely. How would you propose to improve community engagement and public participation while using remote technology (in public hearings, meetings, etc.), particularly to ensure equity in participation?

The technology is there to have meaningful participation and input from the public. The political will is not there. We need to simplify the process and make the public are aware of all their options to participate. This input and the response to it needs to be tracked and open for keep our government accountable.

## **MISCELLANEOUS**

#### 19. New York City has suffered an immensurable loss from the pandemic and its effects and the city's economy, social life, and culture. What is your path to recovery from this crisis?

We need to revive the economy with help to small business such as the Small Business Job Survival

Act and a robust work program paying living wages including for artists (as was done in the Depression) and we need to make sure all are food secure and housing secure through true affordable housing and all have access to proper medical care. This stability will help us get through the crisis.

#### 20. What experience have you had, if any, with good government and reform issues? (e.g. voting and elections, campaign finance, ethics, police accountability, government transparency and oversight). If you've worked to advance these goals, we'd love to hear about it.

I am a proponent of clean, responsive and transparent government. I am the 1st candidate in the history of my district to refuse all donations from real estate developers and lobbyists. I believe we need campaign finance on the state and federal levels along with term limits. I have proposed that all materials given by lobbyists to elected officials should be made public and I am a supporter of open primaries.


