What are your top three campaign promises or goals, and what action will you take to achieve them if elected?

First: 1. Public Safety – East Harlem is the canary in the coal mine. After extensive meetings with DA Bragg's Office, some proposals would bring balance to criminal justice reform. If elected, I would advocate for Discovery Reform adjustments to complete the work of criminal justice reform. Many of these recommendations are supported by multiple entities. Sections of discovery legislation require unrelated paperwork for each case, which prevents expeditious trials and at worse dismissals and declines to prosecute. For example, an individual who was guilty of domestic violence was released due to a missing cab receipt even though it had no bearing on the case. The defense attorney in this case agreed that the individual was guilty but the judge was left with no alternative but to dismiss the case.

Second: 2. 421a Relief Program and 421a - Rev 2.0. Gov Hochul recently called for a renewal of 421a; however, there are questions about a potential rollout. First, we should implement a relief program for those exiting the current program. Within East Harlem, many of the co-operatives founded 20 years ago are sunsetting and will experience a significant property tax burden. Many of these homeowners are retired working-class individuals and now live off of social security and/or their pensions. With the

current rate of inflation combined with the net average pension being 60% of the last year's wage, many homeowners will be displaced. I would advocate for either an individual enrollment program or a building-wide extension of the tax abatement. The second legislation I would advocate for includes a new rollout of the 421a with a limiter on super wealthy developments. The original intent of 421a was to spur affordable homeownership. Unfortunately, many developers took advantage of these programs. The version I have worked on would place guard rails against this exploitation and generate greater socio-economic diversification of new housing stock.

Third: 3. As a junior elected representative, the pragmatist in me knows that reform of our healthcare system and vocational job training programs would most readily pass. Although several healthcare initiatives are under consideration, if they did not pass, I would fight for parity with Medicare reimbursement rates and anti-discrimination legislation as it pertains to doctor-authorized care. For instance, many insurers limit the amount of scans ordered by doctors, even though they are medically necessary. Insurers have placed outside intermediaries/contractors to execute the disapproval of each request. These artificial firewalls prevent individuals from receiving the care they deserve. My legislation would focus on preventing insurers from obfuscating the process.

If elected, what is the first piece of legislation you would want to introduce? If you are an incumbent, what legislation have you passed which you are most proud of? As a pragmatist, I am under no illusions that the above priorities may not be achieved in the first term with the current political environment. Therefore, the first piece of legislation, which is my fourth priority, I would present would be a youth-centered vocational job training program. As I put myself through college, I worked in electrical/plumbing construction and retail. There were once vocational programs in our high schools across the nation. Many of those programs were discontinued. My proposed legislation would create a pipeline of trades school training paired with apprentice programs with participating tradesmen. This program would be paid for by the state to educate the youth and supplement the apprentice program. For example, a master plumber would be able to apprentice a high schooler who could earn revenue and school credit for the trade. Math and science components would be incorporated into the training so that the student would grasp the real-world necessity of their classes.

In providing constituent services, what are the major needs of your district's constituents and how will you meet them? Having organized and coordinated with multiple elected representatives in our district as Chair and Vice-Chair of Community Board 11, the most significant issue faced by constituent services is navigating the bureaucratic agencies of both the city and state. During the past two years, even more people have turned to me as the incumbent's office has limited hours and a lack of understanding of how the city and state agencies interact. With our community being one of the lowest AMIs in the state, it is necessary to help constituents with assistance programs, recertification with NYCHA, and public safety concerns to name a few.

What experience have you had, if any, with good government and reform issues? (e.g. voting and elections, campaign finance, ethics, government transparency and oversight, police accountability). If you've worked to advance these goals, we'd love to hear about it.

Regrettably, I have experienced first-hand difficulties with election reform. We have worked with several District Leaders to bring balance with registration and record keeping; however, more legislation is required to further our goals.

The turnout in the 68th District has been abysmal for many cycles. Combining local elections with statewide would propel more voters to turn out as the return on the investment of time is worth more. Although this will inevitably affect consultants' earnings year to year, their potential clients will remain the same. Ultimately, the greater a population turns out to participate, the better it is for our democracy.

One of the grievances I hear the most is that voters believe they can register on the day of voting. Even changing parties remains limited and stalls participation. If we desire a truly engaged constituency, then we should restart the constitutional amendment process for same-day voting as well as other electoral reforms.

My primary focus is to make it easier for voters to register to vote with a party and not limit their ability to switch. Many independents and former Republicans opined on the difficulty of switching parties. I would propose legislation that would facilitate an extension of the deadline to register to vote and/or switch parties. Moreover, the BOE should be equally accountable to all candidates in the petitioning process. I would advocate for legislation to impact each of these aspects.

Unfortunately, we have witnessed a multitude of issues in our local elections that would be corrected with the training of independent commissioners and top BOE staff. Certain candidates were allowed to stay on the ballot despite not possessing the requisite amount of signatures (i.e. non-qualifying signatures were included). We have also witnessed the removal of individuals from the party rolls. Personally, my name was removed from the Democratic rolls and I was forced to pull up every record from the very first year voted. As a result, they acknowledged their mistake but still denied my participation in a primary. The subsequent year, they rectified my registration. Ironically, they removed me but not my wife on the claim that I had not voted when in fact I had. Properly trained staff would prevent such occurrences. Legislation should be presented to remedy these issues.

The disclosure is helpful for transparency; however, many large institutions possess stricter protocols that prevent contributions to normal state and local campaigns. Those participating in the Campaign Finance program already must provide the employer's information above a certain contribution amount.

11. Who do you think should draw new district maps every decade in New York? (e.g., the current Independent Redistricting Commission, the Legislature/LATFOR, a new body)

The Independent Redistricting Commission is the most appropriate body to assess our district maps. Nothing reaffirms this position more than the lawsuit from the new maps issued by the Legislature, which resulted in a loss of seats in Congress. Allowing a review by the Legislature is helpful when partisan politics can be set aside. Unfortunately, this last iteration fell short of that ideal. Representative democracy works best when all voters are engaged. The IRC should be afforded an oversight mechanism to prevent subsequent partisan redrawing.

12. Do you support changing the constitutional redistricting process to reduce the influence of legislators over map-making process, make the redistricting commission less partisan and more diverse, and eliminate the Legislature's veto power over final maps?

The IRC placed an incredible amount of discerning, thoughtful effort into our maps that were fair, balanced, and equitable. The Legislature's veto and subsequent State Senate and Congressional maps issued were akin to Republican efforts in other parts of the country but without the analytical mathematics. As stated above, an oversight mechanism should be granted to the IRC to counter a veto.

To offer context in support of a truly independent IRC, it is important to examine what happened with the Senate Seats covering East Harlem and the Upper East Side. Sen. Gianaris (who oversaw the process) redrew maps that consolidated Queens and then took a segment of East Harlem and Yorkville. This massive overstep flew in the face of the IRC's proposals. It possessed neither demographic nor geographical context for justification. An independent IRC with an override mechanism would bring balance to partisan politics and create an equitable district map.

All agencies should be accountable to the public for their actions. Case in point, DOHMH has caused irreparable harm due to policy decisions from the past two administrations. Unfortunately, there is no oversight mechanism for accountability. For a more just and equitable city and state, public trust must be restored. As a producer, we bring competing interests (investors, unions, talent, crew, distributors, studios, city/state agencies, etc.) to negotiations that often become diametrically opposed at their peak, yet we find agreements to roll out a successful project. If elected, I will gladly play an integral role in bringing all parties to the table to create successful solutions and restore public trust in our NYPD and other agencies.
