campaign promises or goals, and what action will you take	First: We must address the housing and affordabi York by dramatically increasing the supply of hou

and what action will you take to achieve them if elected?

First: We must address the housing and affordability crisis in New York by dramatically increasing the supply of housing, while also fighting vigorously to protect the rights of tenants and preserve the affordable housing that we have. I was very proud to help craft Governor Hochul's proposed New York Housing Compact, and I would work hard in the Legislature to advance legislation along the same lines that would aim to spur housing production and overcome decades of racist, exclusionary zoning that has the effect of creating enormous economic pressure on all New Yorkers.

Second: I will fight for increased investment in mental health services, including more inpatient beds, supportive housing, and

outpatient services. I'll also work to make sure individuals don't fall through the cracks of the system, and to enact new laws and regulations that hold hospitals and insurance companies accountable for admission and discharge decisions that put patients first. I'll work to see through the expansion of schoolbased mental health services and the enactment of legislation to curb social media companies' use of addictive, algorithm-driven feeds.

Third: I will work with colleagues and legal experts to formulate legislative strategies in anticipation of, and in response to, actions by other states and the Federal government and decisions by the Supreme Court that aim to weaken New York State laws and liberties. I was proud to help craft the legislative response to the Dobbs and Bruen decisions and believe, unfortunately, that the need for work in this area will only expand in the years to come.

I don't know if it would be my very first piece of legislation, but I am extremely interested in crafting legislation that would incentivize the timely completion of Local Law 11 work and the removal of sidewalk sheds that seemingly cover entire swaths of neighborhoods; likewise, I would like to pursue legislative strategies to discourage long-term vacancies in commercial storefronts.

The needs of this district are wide-ranging, and the district's residents are socioeconomically diverse. There are large NYCHA developments in the district, where residents live with the acute needs of public housing. Significant amounts of Mitchell-Lama and HDFC housing struggle with operational challenges, while tenants — both rent-regulated and market rate — face growing economic pressure. There are excellent public schools in the district, but real inequities exist between schools serving more affluent populations and those serving families with greater levels of need. We have wonderful parks and public spaces in the district, but there are chronic infrastructure, staffing, and resource needs. And the intersection of streetscape issues (scaffolding, vacant storefronts), crime, and mental health challenges have given rise to growing neighborhood concerns about safety.

There is no single answer to how best to help constituents with these issues. I will run a hard-working, diligent, competent district office, with full-time Spanish-speaking staff, focused not just on being responsive to constituents, but seeking them out. We will track follow-up, and establish systems (if the office does not already have them in place) to quantify how well we are addressing individual constituent requests and needs. At the same time, we will work to establish relationships with a broad array of organizations and stakeholders in the district so we can be proactive partners in helping them meet their needs and address local concerns.

I have a long history of working on good government and reform issues.

In 2003, I worked closely with several members of the State Assembly to enact the first significant rules reforms in the Legislature in a generation, including the end of empty-seat voting.

In 2015, as Chief of Staff in the Office of the New York State Attorney General, I worked closely with Citizens Union to draft and advocate for the End Corruption Now Act, which was the Attorney General's omnibus reform legislation. It included sweeping campaign finance reform, with dramatically lower contribution limits, public matching funds, closure of the LLC loophole, pay-to-play restrictions, and an end to housekeeping accounts; a ban on outside income for legislators and an end to per diems, paired with an increase in legislative salaries; and substantial strengthening of the statutes and powers available to law enforcement to investigate and prosecute public corruption, including a grant of original jurisdiction to the State Attorney General. Many of these proposals, in some form, have become law in the intervening years, and I would look forward to working with Citizens Union to advancing those that have not.

I have also been proud to work with Citizens Union to expand the franchise. Specifically, following discussions with Citizens Union and a request from Suffolk County, the Attorney General's Office, during my time as Chief of Staff, issued a landmark opinion to allow for online voter

There is a great deal more work to do to make it easier for New Yorkers to register to vote and cast their ballots – and it is work that I will focus on in the Assembly.
