What are your top three campaign promises or goals, and what action will you take to achieve them if elected?

First: Housing – Harlem faces both a housing shortage and an affordable housing shortage. Folks who have grown up here are being priced out, and as the epicenter of Black political life and culture in this country, Harlem cannot afford to allow this affordability crisis to persist.

Second: Jobs – We must prepare Harlem's workers for the jobs of the future.

Third: Youth Services – We must support the true growth and development of our youth.

If elected, what is the first piece of legislation you would want to introduce? If you are an incumbent, what legislation have you passed which you are most proud of? Ultimately, if elected, supporting my community boils down to ensuring public safety. To do so, we must tackle some of the root causes of crime, chief among them being the inability to afford a home or obtain a goodpaying job. Therefore, while I am deeply hopeful that Albany acts on a well-rounded bill to tackle the affordable housing crisis, as of now, a strong piece of legislation will be my immediate priority. To do so, we must ensure that tax incentives are sufficient to actually promote development and that

measures are put in place to affirm that good-paying union jobs will be at the base of any incentive. If we can build more affordable housing for folks to live in, and if we can build that very affordable housing by creating local union jobs, we will have chipped away at two of the root causes of our present issues with public safety.

In providing constituent services, what are the major needs of your district's constituents and how will you meet them?

In the 70th Assembly District, the issue I hear most as I walk the streets of my community is affordable housing. We have a shortage in Harlem and across this city and state, and when affordable units do come available, they are often difficult to find before they get swept off the market. My constituent services team will be prepared to connect residents to affordable housing opportunities as they arise, especially as I continue my fight for more affordable housing through legislation.

What experience have you had, if any, with good government and reform issues? (e.g. voting and elections, campaign finance, ethics, government transparency and oversight, police accountability). If you've worked to advance these goals, we'd love to hear about it.

As Chief of Staff to NYC Council Member Yusef Salaam, I stood behind the How Many Stops Act, whose sole aim was to increase data collection around substantive police interactions. Also, I will continue to advocate for more community-based policing so that communities can truly get to know the officers tasked with keeping them safe. In the Assembly, I will fight for police accountability and good government reforms supporting nonpartisan redistricting efforts, ethical campaign finance, and increased government transparency.

I have a Field and Communications team working on ambitious plans for physical and virtual outreach to voters, and I have a large team of advisors in the field, policy, fundraising, and faith communities supporting my efforts.
