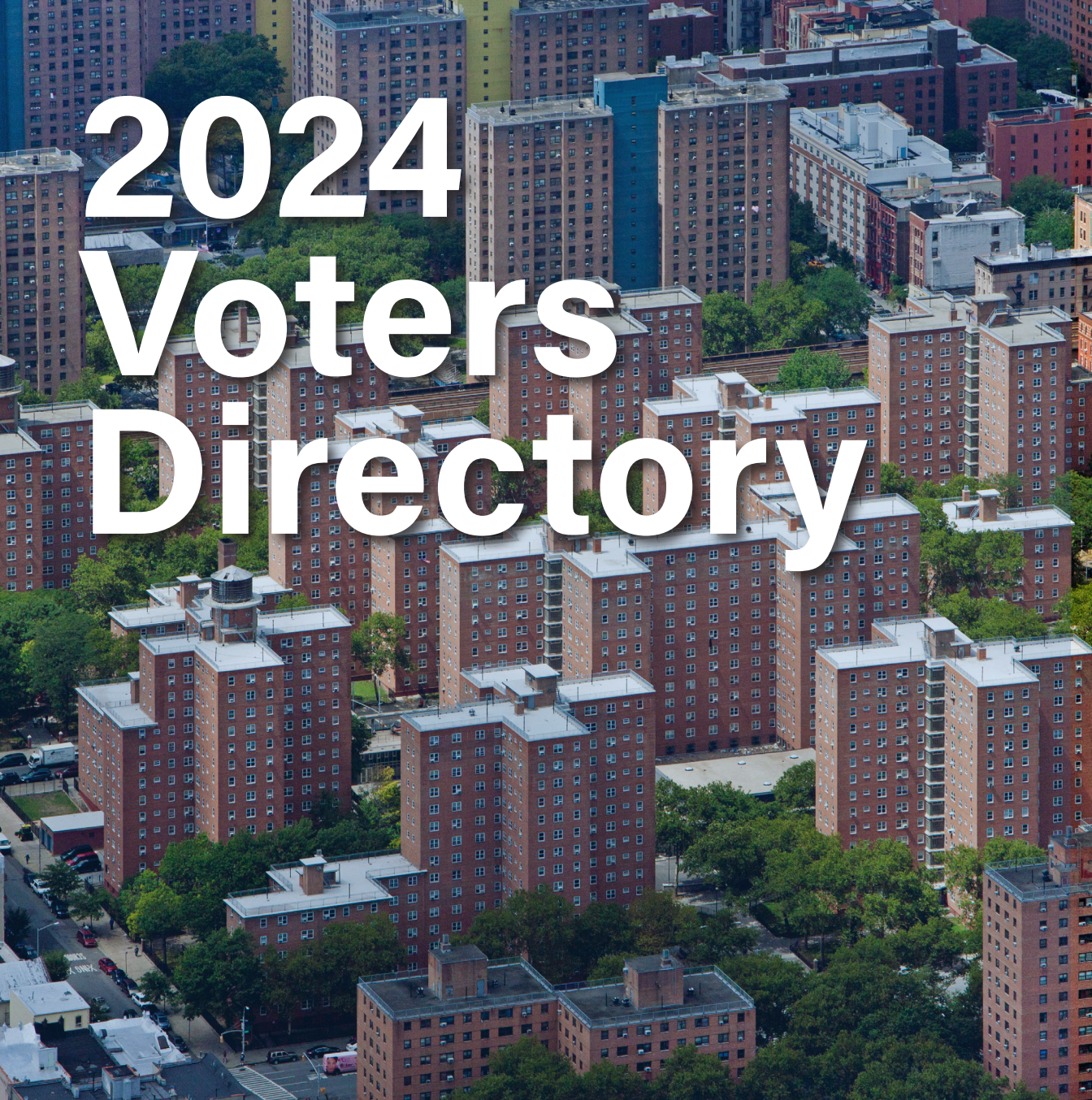

Of the 93 seats in the New York State Legislature representing New York City residents:

- 74 incumbents are uncontested in the primaries. That means that 79% of all of NYC's seats in the state legislature are held by incumbents who do not face any competition in their parties.
- In the State Senate, 27 of NYC's 28 seats – or 96% – are held by incumbents who are running for re-election without primary challengers. There is only one contested race in the 59th Senatorial District.
- In the Assembly, 47 of NYC's 65 seats – or 72% – are held by incumbents who are running for re-election without primary challengers.

This is the highest rate of uncontested races since Citizens Union began monitoring this data over 10 years ago. Rate of uncontested incumbents in the primary:

OVERVIEW

Citizens Union evaluated 16 candidates in 7 races for New York State Assembly to determine who strongly supports our issues, can advance a reform agenda, and can best fulfill the obligations of the position.

Interview teams made up of Local Candidates Committee members and Citizens Union Board members assessed the candidates based on their responses to Citizens Union’s questionnaire, independent research, first-hand knowledge of the candidates, and interviews with the candidates. The interview teams then made advisory recommendations to the full Local Candidates Committee, which deliberated and made recommendations to the Citizens Union Board, which made the final decision. The result of that evaluation is detailed in this Voters Directory, which Citizens Union has been publishing as a guide to its supportive members for over a century. All interviews and meetings were held by video conference.

A “Preferred” rating reflects a candidate that Citizens Union deems not only qualified for the office, but also a viable candidate, committed to an agenda of positive reform. Please note that candidates not preferred may nevertheless be highly regarded, which is generally reflected in the commentary.

Citizens Union issues a “Preferred” rating in primary elections, and an “Endorsed” rating for general election contests. A “No Preference” rating may result when there is insufficient information available, it is believed that the candidates are of equal merit, or if no candidate interviewed by Citizens Union is believed to be effective or capable of representing the district. A “Dual Preference” designation may be offered to two qualified candidates, but not a “Dual Endorsement.” A “Dual Preference” shall be used only as a last resort, and, in the case of such determination, CU shall explain its reasoning in its Voters Directory.

OUR CRITERIA

The following guidelines are used by the Local Candidates Committee and Citizens Union Board of Directors in the evaluation of candidates:

- Support for Citizens Union's reform agenda is the primary criterion used in deciding our support for a candidate.
- Other criteria considered in evaluating candidates and campaigns:
 - » A record of ethical integrity.
 - » Commitment and ability to advance CU's goals, if elected
 - » For incumbents: demonstrated support for CU's issues while in office
 - » Evidence of ability to wage an effective and competitive campaign
 - » Reliance on small-donor, local financing of the campaign
 - » Candidates' grasp of issues specific to the race's jurisdiction, and whether they propose thoughtful solutions to represent constituents' interests

Evaluation of the candidates and the decision to support a particular candidate shall be made without regard to political party and in a nonpartisan manner.

NY ASSEMBLY DISTRICT 50

Greenpoint, Williamsburg

Emily Gallagher ★ Preferred Candidate

Age: 40 Occupation: New York State Assembly Member, 50th District

Education: Ithaca College (B.A.); Baruch (M.P.A.)

Emily Gallagher was elected to the Assembly in 2020, unseating a nearly 50-year incumbent, and now chairs the subcommittee on child product safety. She has been a strong supporter of the reform agenda before being elected to office and during her first two terms, and has backed CU-supported bills. Gallagher introduced and championed the LLC Transparency Act to increase transparency of ownerships of limited liability companies, which was signed by the Governor into law, albeit with some changes. She supported all policy questions in CU's candidate questionnaire. CU has supported Gallagher in her first election, and appreciates how she has maintained the same positions. She was honest about the challenges of the legislative process and what it takes to navigate the Albany power structures. CU prefers Gallagher because of her commitment to reform issues, track record on the issues, and experience working with the community.

Anathea Simpkins

Age: 52 Occupation: Associate Vice President of the Say Something Anonymous Reporting System, Sandy Hook Promise

Education: Emerson College (B.F.A.) UMass Amherst (M.Ed.)

Anathea Simpkins is a former public school teacher who became involved in gun violence prevention work, and now serves as vice president at Sandy Hook Promise. A dedicated activist who is particularly knowledgeable on education and youth mental health issues, Simpkins told CU she sees "conversation, collaboration, and compromise" as key tenets of her approach to politics and that she hoped to unify the district's generations and political factions. She supported all CU's policy questionnaire items, and expressed commitment to the reform agenda, with a particular interest in

fair redistricting. CU values her dedication to her community and encourages her to stay civically involved.

NY ASSEMBLY DISTRICT 52

Brooklyn Heights, Downtown Brooklyn, Cobble Hill, Carroll Gardens, Gowanus, Prospect Heights, Park Slope, Boerum Hill, DUMBO

Jo Anne Simon ★ *Preferred Candidate*

Age: 71 Occupation: New York State Assembly Member, 52nd District

Education: Iona College (B.A); Gallaudet University (M.A.) Fordham University (J.D.)

Jo Anne Simon has represented this Assembly District for the past ten years, and now faces her first primary challenger. She serves as chair of the Committee on Ethics and Guidance and the Legislative Ethics Commission. Before entering politics, Simon founded a disability civil rights law firm in Downtown Brooklyn. She has a long record in advocating for voting rights, government and police transparency, and has authored important reform legislation, including bills to close the LLC loophole (passed in 2019), move NYPD disciplinary hearings to OATH, and limit last-minute changes to the location of poll sites. However, Simon differed from CU on several issues. She opposed replacing the current Legislative Ethics Commission – which she co-chairs – with an independent ethics agency, was against removing the map-making power from the legislature, and defended the campaign finance bill passed by the legislature last year, which CU strongly opposed. During her interview, Citizens Union was impressed by Simon’s knowledge of the issues and the clarity of thought put into her objections, which often included support for broader reform issues even when the details did not align with Citizens Union’s proposals. Citizens Union encourages Simon to reconsider her positions on these issues, but given her record and effectiveness as a legislator, and the years of skillful service for her district, we prefer her in this race.

Scott Budow

Age: 35 Occupation: Associate at Kauff McGuire & Margolis LLP

Education: Cornell University (B.A); Fordham University (J.D.)

Scott Budow is an associate at Kauff McGuire & Margolis’ Labor and Employment Group. Born and raised in New York City, he had previously been a union organizer and Adjunct Law Professor at Fordham. Budow supported all of CU’s questionnaire policy items,

and his campaign also proposes to restore the vote for incarcerated individuals, move to an open primary system, and give the CCRB more power to investigate misconduct within the police department. Citizens Union was impressed by Budow's in-depth, detailed responses and his understanding of local and state government, and we encourage him to remain in electoral politics.

NY ASSEMBLY DISTRICT 56

Bedford-Stuyvesant, Northern Crown Heights

Stefani Zinerman ★ *Preferred Candidate*

Age: 59 Occupation: New York State Assembly Member, 56th District

Education: Rochester Institute of Technology (B.A)

Stefani Zinerman has represented Bedford-Stuyvesant and northern Crown Heights since 2021, having grown up in NYCHA's Gowanus Houses and moving to Bed-Stuy 17 years ago. Her family has resided in the district for three generations, and she stated that their civic involvement was an inspiration for her to become involved in politics. She previously served as chief of staff to Council Member Robert Cornegy and as special projects manager to former State Senator Velmanette Montgomery. In Albany, she chairs the Subcommittee on Emerging Workforce; eight of her bills were signed into law. One of those bills required ballot questions be written in plain language for more voters to understand them. She also co-sponsored other election-related reform bills. She opposed several CU priorities on the questionnaire, including same-day voter registration, merit-based hiring in boards of elections, and removing the legislature's power over final district maps. However, she offered more nuanced answers during her interview and expressed openness to discussing and modifying some of her positions. Citizens Union prefers Zinerman in this race because of her experience and effectiveness in office, thoughtful discussion, and civic engagement work in the community.

Eon Tyrell Huntley

Age: 39 Occupation: Sales Representative, Bergdorf Goodman

Education: Parsons School of Design (degree unknown);

Eon Huntley is a retail worker, former union organizer, and former Parent-Teacher Association president who grew up in East New York in NYCHA and Mitchell-Lama housing. He has lived in Bedford-

Stuyvesant for 15 years and was most recently president of his daughter's school's PTA. During his time on the PTA, he worked with a local nonprofit to start a community food bank at the school in order to help neighbors in need amidst the COVID-19 pandemic. Huntley supported all of CU's reform agenda and stated that if elected, his first reform priority would be campaign finance reform to dissuade the influence of large donors. Citizens Union is impressed by Huntley's political drive, community involvement, and support for reform, and encourages him to continue his work on these issues.

Xavier Santiago★ Preferred Candidate

Age: 45 Occupation: Film Producer

Education: Bowdoin College (B.A); American Academy of Dramatic Arts (A.A.)

Columbia University (professional certificate)

Xavier Santiago is a film producer and the current chair of Manhattan Community Board 11. He has lived in East Harlem for 16 years and has been involved in local civic work related to economic mobility and voter access. Santiago supported all CU's policy questionnaire items, and presented an excellent technical grasp of reform issues, including on BOE reform, redistricting, and voting accessibility. He would seek a seat on the oversight committee and push for more transparency in Albany. He also prioritizes easier party enrollment before a primary. On non reform issues, Santiago emphasizes his plans to strengthen constituent services and community relations. His alignment with the reform agenda and focus on community work earned him our preference in this race.

Eddie Gibbs

Age: 55 Occupation: New York State Assembly Member; 68th District

Education: Cayuga Community College (A.B.A.);

Eddie Gibbs is completing his first full term in the Assembly, after first winning a special election to replace Robert Rodriguez in 2022. He is the second formerly incarcerated person in the nation and the first in New York to serve in a state legislature. In Albany, he has been a strong champion for the rights of incarcerated people and supporting the reentry community. Five of his bills were signed into law, including a bill providing notice of voting rights for people released from jails. Citizens Union commends Gibbs for providing an important voice that is needed in Albany.

Tamika Mapp

Upper West Side, Bloomingdale, Manhattan Valley, Morningside Heights

Micah Lasher ★ Preferred Candidate

Age: 42 Occupation: Full Time Candidate

Education: New York University (B.A.)

Micah Lasher has worked in city and state government for over two decades. He was one of the founders of SKDK, served in the Bloomberg administration and under AG Eric Schneiderman, ran Scott Stringer's 2021 mayoral campaign, and in his most recent position was Director of Policy for Governor Kathy Hochul. He is also involved in several civic groups in the Upper West Side and Morningside Heights. Lasher supported all of CU's reform agenda, and spoke about his experience working on Assembly rules reforms and anti-corruption legislation. He also said he would prioritize reducing pay-to-play politics. Lasher is well-versed in the issues, challenges, and needs of reform and government accountability, and his extensive background in government and politics would make him a more effective member of the Assembly. Citizens Union prefers him in this race.

Eli Northrup

Age: 39 Occupation: Full time candidate

Education: Cornell University (B.A.); New York University (J.D.); Georgetown University (L.L.M.)

A public defender and policy director at the Bronx Defenders, Eli Northrup dedicated his career to representing and advocating for justice-involved individuals. Most recently, he led the Cannabis Project, helping formerly incarcerated people apply for dispensary licenses, and before that he clerked on the Third Circuit Court of Appeals and the Southern District of New York, and worked for the NAACP and the Legal Aid Society. Northrup says he is seeking office to give voice to those who feel abandoned by the government, people he often represented in court. He supports all of CU's reform agenda in the questionnaire, and has experience advocating for measures to increase police accountability, including repealing

Melissa Rosenberg

Age: 33 Occupation: Full time candidate

Education: McGill University (B.A.); New York University (M.P.A.)

A VP of Real Estate at Kasirer until resigning to run for office, Melissa Rosenberg has spent her career focused on housing development. Among the projects she recently worked on is Innovation QNS, mixed-use complex in Astoria that was approved by the City Council. She also co-chairs the housing committee on Manhattan Community Board 7. Previously, she worked as an analyst for the Supportive Housing Network of New York and the city's Office of Management and Budget. Rosenberg supported all of CU's reform agenda and said she would focus on issues of ethics and transparency, as well as improving elections. On non-reform issues, she would prioritize working on housing and transit accessibility in the district. Citizens Union appreciates Rosenberg's dedication to her community and encourages her to continue her civic participation.

Jack Kellner

This candidate was not available for an interview.

Carmen Quinones

circles of Harlem, and has also worked teaching and in after-school programs. Last year, Wright ran Yusef Salaam's campaign for City Council, and after Salaam's surprising victory Wright was appointed his chief of staff. He is now running to represent the same area in the Assembly. Wright supported all CU's policy questionnaire items, including the ones meant to reduce influence of parties over elections, and suggested that the New York City Board of Elections needs representation for independent, unaffiliated voters, instead of only Democratic and Republican commissioners. Wright made a compelling case for his "independence" despite his close ties with party leadership, and exhibited a good understanding of state politics and reform issues. We prefer him in his race because of his commitment to reform issues, and his ability to deliver on the community's priorities.

Shana Harmongoff

Age: 46 Occupation: Full Time Candidate

Education: South Carolina State University (B.S.); Appalachian School of Law (J.D., J.M.)

Shana Harmongoff is an attorney who previously served as a staffer for former State Senator Brian Benjamin. Among other things, she oversaw pandemic relief efforts in Harlem and East Harlem. Her campaign focuses on advocacy for senior rights and supporting seniors, and she stresses being the only candidate in the race with experience working in the legislature. Harmongoff demonstrated impressive communication skills and creativity in her responses to policy questions. She supported all of CU's reform agenda.

Maria Ordoñez

Age: 24 Occupation: State Committee Member in Assembly District 70

Education: Columbia University (B.S.)

Born and raised in Harlem, Ordoñez is a community activist and tenant organizer. She is a Local Political Director of the Manhattan Young Democrats, a party State Committee Member for this district, and a member of Executive Committee Member in New York Progressive Action. She is running to represent the people of West Harlem, who she says have been neglected by party leaders. Her campaign prioritizes housing and healthcare issues. Ordoñez supported all of CU's reform agenda, and showed deep familiarity with problems related to election administration, noting that same-

Juan Ardila is the freshman incumbent in this seat, having won a competitive Democratic primary in 2022. He was a community organizer in Queens for much of his life, working for some time at the Legal Aid Society. During his first term, Ardila got three of his bills signed into law related to medical assistance, elderly care, and an emergency alert system. He supports all of CU's reform agenda and has co-sponsored bills on BOE reform and voting. Much of his current focus is on constituent services. In his interview with CU, he spoke about his work assisting local businesses, organizing donations for new migrants, and supporting people displaced by fires in the district. At the beginning of his term, Ardila was accused of sexual assault at a college party a decade earlier. He denied the allegations and noted in his interview that no investigation ever materialized. They have spurred calls for his resignation from his former allies and state leaders. Citizens Union appreciates Ardila's commitment to reform and his dedication for his community, but is concerned that the political ramifications of the accusations made against him impedes his effectiveness as a lawmaker. We issue a no preference in this race.

Claire Valdez
