INTRODUCTION

1. What are your top three campaign promises or goals, and what action will you take to achieve them if elected?

Promise 1: Lower the Cost of Living by cutting down on taxes and fees.

Promise 2: Shift more funding to the NYPD and get more police officers hired.

Promise 3: Improve local quality of life by going after package theft, and illegal dumping.

2. If elected, what is the first piece of legislation you would introduce? Why is that your top priority? If you are an incumbent, please also state what legislation you have passed which you are most proud of.

I would work to pass "Priscilla's Law" to require license plates and registration for e-scooters and electric bikes not covered by the DMV. We need more accountability from individuals using e-scooters and e-bikes, especially if they are endangering people on the sidewalk.

3. In your view, what are the major needs of your district's constituents?

I have a diverse district with different needs. The top priorities across the board though is affordability and safety. In Coney Island there still is infrastructure problems lingering from Hurricane Katrina, and a need for more jobs. In Bath Beach there are problems related to traffic and illegal dumping. In Bay Ridge we have to continue work on revitalizing 86th street shopping corridor.

4. How long have you lived in the district in which you are running, and do you have any achievements or involvement in your neighborhood you are particularly proud of?

I've lived in Bay Ridge for over 25 years and have run my business here for about the same amount of time. My wife and I have both been active members of the SLT at PS/IS 104, and she now serves as the newest member of the SLT at Mark Twain Middle School. Together, we've also been deeply involved with the Greek School of Plato, where we have both served on the board.

In addition, I've contributed to and participated in numerous holiday toy giveaways for children, and I previously served as Chairman of the National Association of ATM Operators (NATMC), a national trade organization for independent ATM operators.

5. What experience have you had with good government and reform issues? (e.g., voting and election reform, campaign finance, ethics, police accountability, government transparency). If you've worked to advance these goals, we'd love to hear about it.

I have always been outsider and critic of the party politics in New York City. During my own primary potential voter fraud within the Board of Elections was discovered, and I worked to bring that to light. Especially due to the fact that my opponent in the primary was also the Kings County Party Chair which oversees appointments to the Board of Elections. I am against the Tammany Hall style game of appointments for favors both from elected officials and party bosses. If elected I would champion reforms that prioritize merit in civil service over appointments, and go after corrupt officials in city departments. I would also work to hold organizations that get discretionary funding from council members accountable.

6. What do you think the role of the City Council is in city government this upcoming term?

I believe that the role of Council Members is to bring their neighborhoods diverse and unique voices to city government. I also believe in the Council's responsibility in holding the Mayor to account whoever it may end up being.

ELECTIONS AND VOTING

7. Do you support moving New York City's elections from odd-numbered years to even-numbered years, and will you co-sponsor a Council Resolution supporting that measure?

Voter turnout in New York City elections is exceptionally low, as they are held "off-cycle" in odd-numbered years. To boost local voter turnout and reduce participation gaps, the Legislature passed and Governor Hochul signed a law that moves county and town elections to even-numbered years, and lawmakers are supporting a constitutional amendment that would do the same for city elections, including New York City's. Citizens Union is Leading a coalition of groups advocating to move New York City's elections to even-numbered years, and the City Council is considering a Resolution in support of that shift.

The City Council appoints NYC BOE members and has the power to appoint commissioners who are committed to reform, but the most recent commissioners have been appointed behind closed doors. Do you commit to request a public hearing for BOE nominees, and to only vote for individuals who are publicly committed to reducing party-based patronage and supporting open hiring practices?

I do support shifting local elections to even numbered years as it will increase citizen participation.

I will prioritize merit in my office and hire only based on that and not "party promises or affiliations". I will be open and hold non-profits that get discretionary funding from office accountable. I will also commit to holding town halls and State of the District forums throughout my term.
