ELECTIONS AND VOTING

Election Administration

CAMPAIGN FINANCE

I believe it is a way to level the playing field and eventually separate private funds/interests from the electoral process.

GOALS, PLANS, AND REPRESENTATION

What are the top three campaign promises or goals, and what action will you take to achieve them if elected? Feel free to reference an answer above rather than restate it.

First: Housing - Protect NYCHA from privatization, expand fair market voucher programs and create new opportunities for comprehensive social housing at all income levels.

Second: Healthcare - ensure all New Yorkers have access to quality healthcare which integrates vision and dental

Third: Education - ensure that New York City schools get the funding they deserve and that every family has access to the resources and services they need like Wifi and expand access to our public higher education system.

If elected, what is the first piece of legislation you would want to introduce? If you are an incumbent, what is the first piece of legislation you would want to pass?

There are several bills I'd be happy to sponsor as my first piece of legislation including unnecessary barriers for NYCHA residents like myself or a bill that ensures the longevity of NYCHA as a fully public entity.

In providing constituent service, what are the major needs of your district's constituents and how will you meet them?

There are so many resources but a lack of engagement and transportation mean many people in my community face tremendous barriers in receiving services of any kind.

In particular:

Transportation: I am blind in my left eye, so I am unable to drive and transportation access is extremely important to New Yorkers like me. There is no subway on Staten Island bus service can be unreliable, some communities have no sidewalks, there is no ferry service between the Brooklyn and Staten Island portions of our district. This has to change I plan to ensure our state is investing in the infrastructure our community needs.

Housing - We must not only pass Right to Council, Housing Voucher Access and Just Cause we need to ensure we bring them directly to the people. I plan to do proactive community outreach (as I have before reaching office) through in person, mail and digital outreach.

Healthcare - I have a background in Public Health; I'm committed to bringing more healthcare resources to our district. South Brooklyn and the South Shore of Staten Island are underserved. We also need to ensure every community member knows what options are available to them regardless of income or status.

Education

I do a Diversity Equity and Inclusion consulting including with some city agencies. I've had the opportunity to help city agencies reimagine what equitable hiring looks like and how we build and maintain work environments that are rich with diverse perspectives.

Within my community I have also worked facilitating a number of grants and special assistance programs including LRAP, ERAP and other emergency assistance.

I've taught my children to register voters and carry registration forms in my purse.

I've worked Staten Island Women Who March and was one of the primary organizers for marches calling for police accountability for the Garner family, Breonna Taylor and others harmed by police violence.

My team is undertaking a comprehensive voter engagement plan with consultants and other candidates who know the district well.

I have the IDs of several current and former candidates who share my values and have already began engaging those voters.

We strongly believe that organizing and engagement are the best ways to win this race and are raising the funds necessary to mount data informed targeted digital outreach, door knocking, registration and voter engagement. All of our current and future consultants have worked on races in the 23rd district.

I plan to leverage my organizing, legislative and connections to the Brooklyn Council of Churches to maximize outreach on the Brooklyn side of the district.
